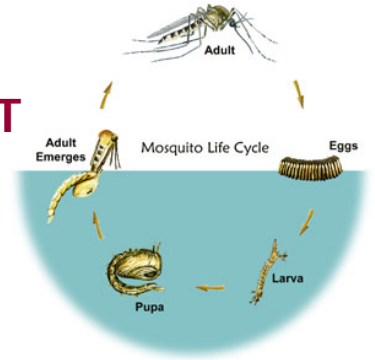


MMCA MISSION STATEMENT

The Michigan Mosquito Control Association (MMCA) was formed in 1986. It advocates the suppression of mosquitoes and vector-transmitted diseases of public health importance through scientifically sound control methods.

The MMCA also serves as a forum by which the scientific community can address legislative issues to Michigan legislators and others on the control of mosquitoes and mosquito-borne diseases.

The Michigan Mosquito Control Association is comprised of professionals in the field of mosquito control, public health officials, university researchers, private pest control operators, government officials, representatives from the business industry, and interested citizens.
